

At January 21, 2015, all shares were allocated to the accounts of participants, who have power to direct the voting of such shares. The Trustee may dispose of shares held in the ESOP Trust or vote the shares contrary to the instructions of participants only under limited circumstances specified in the ESOP or by law. Bankers Trust has been assigned as the special independent fiduciary of the ESOP with respect to the Merger with People's Bancorp, Inc. and has the power to vote the shares in the ESOP in connection with the Merger. NBTC also has sole voting and sole dispostive power with respect to 130,077 and 161,401 shares, respecitively, held as Trustee for various other trusts.
