

Change: If the branch information is incorrect or incomplete, revise the data, enter 'Change' in the Data Action column and the sale or dosure date in the Effective Date column.

Close: If a branch listed was sold or closed, enter 'Close' in the Data Action column and the sale or dosure date in the Effective Date column.

Online: If a branch listed was never owned by this depository institution, enter 'Oelere' in the Data Action column and the opening or acquisition date in the Effective Date column.
