

(1) The Hocking Valley Bank, Athens, Ohio is a wholly-owned subsidiary of Hocking Valley BancShares, Inc. The Hocking Valley Bank holds 100% equity in a subsidiary named Net Enterprises, Inc which engages in computer networking software, hardware and support for the bank.

Additionally, the holding company has 100% ownership of HVBS Holdings, LLC which owns a 99-space parking lot approximately adjacent to the bank.

The company owns no interest of any kind in any other entity at this time. All the above businesses are headquartered on Stimson Avenue in Athens and do business primarily in Athens County Ohio.

We do not have knowledge of the beneficial owners of the remaining 7,260 shares. Although we believe that many of the shares held at Wells Fargo are locally owned we are not privy to the holders nor to the aggregate number of shares held.
